vote for the change in bylaws – it was voted unanimously for the change by your president and the rest of the BOD.


You will be receiving your dues notice for next year. Please remit promptly to reduce the workload on our (both) overworked Secretary and Treasurer.


#### 43rd Annual Southern Division Banquet at Antonio's



## Southern Division Board Meeting Minutes Friday, Aug. 14, 2009—Boca Raton Marriott

President Charles Anyan called the meeting to order at 4:06 P. M. Secretary Dienzel Dennis called the roll with the following present: President Charles Anyan, Treasurer Mike Powell, Secretary Dienzel Dennis, and Directors Arnie Travitsky and Steve Harris. Also in attendance were meet host Mike Setzer, Richard Tashjian, Chris Lucibello and Dick Guenette. Vice President Will Wagner arrived at 4:40 and Web Master Jake Jacobs at 5:02 p. m.

Mike gave an update on tomorrows meet status. We are sold out of tables and have a waiting list. There is a small problem with tables. We may have to use some 6 foot tables since we don't have enough 8 foot. This was worked out to an acceptable conclusion. A few members are bringing their own tables from home. Mike thanked the board for the ad in the Palm Beach Post newspaper and a copy was passed around for all to see. The Treasurer will pick up funds occasionally from the front desk for security reasons. Door prize procedures were discussed and it was decided to change this for all future meets. However, for the meet tomorrow, a certificate will be presented, by drawing, for a free table (\$20.00) for current table holders. One gift, compliments of TCA, will be awarded to a TCA member. A motion by Mike Powell was made and passed allowing a gift to any lady who works the front desk or any other capacity at this meet. Also, one other door prize for a lady attending the meet. You must be present at the time of the drawing to win.

Since we are missing a communications officer, President Anyan will handle the National E-blast for meets. Arnie Travitsky will handle the national free ads and Will Wagner will work with the Manufacturer Ads. (Lionel, MTH, Atlas, etc.) Mr. Jacobs will also do the National Quarterly ¼ page ad. The president will work with local meet host for all local meet advertising.

Mike Powell will chair a committee with Dienzel Dennis and Will Wagner's help in revising our Bylaws to satisfy changes required by the National Club. At the same time we will work on a Southern Division Officer's Handbook. Mr. Anyan will collect names/emails for all general public attending the meet tomorrow. This will be used to announce the next meet in this area, as well as a recruiting tool for the SD. Charlie will continue to work on the Meet Host Checklist handbook. A meet committee will be decided at a later date. However, the president has had great success in securing a meet in Jacksonville and some of us will be traveling there within the next few weeks to finalize this meet. It will hopefully be on May 15 with May 22 as an alternate date. The Courtyard by Marriott will be the site with Chuck Bryner as the local host.

We discussed at length the pros and cons of a secure area on our website. Should the layout be available to members only or also to the general public? Will Wagner and Jake Jacobs will work on this and report back within a month.

A discussion on ads in the layout led to a decision to require members to submit ads for each issue. They will not be carried over to the next issue unless resubmitted by the member. This will be announced in the next "Layout." The possibility of Paid Commercial Ads was tabled until the next board meeting.

The layout that was donated to our division will be stored in the Warbird museum for the time being with Arnie handling this project. We discussed donations to the National museum and this will be decided at our next meeting. Also discussed were donations and solicitations of donations to the Southern Division.

It was decided that a meet table holder with one table could bring one helper with him "free of charge" and a member with 2 or more tables would be permitted to bring 2 helpers "free of charge".

Our annual Banquet will be held after the Maitland meet at "Antonio's" near the civic center. Will Wagner made a motion with a second by Arnie Travistky that we finalize the plans with the price of \$39.80 per person as recommended by our president. The banquet will be subsidized as necessary by the SD to assure that the price per member will not exceed \$39.80

The **SD** members working on the Ronald McDonald House Layout requested funding, not to exceed \$100.00, to update the layout to include automatic operation for a few minutes when a button is pressed. The house cannot have someone available at all times to operate the layout, so this will allow it to be run at anytime by anyone. The President approved the request. The treasurer will reimburse the members when the receipt for materials is received.

Secretary Dennis reported that we have 509 members listed in the data base. Of this number, 8 have deceased during the past year and 54 our inactive from lack of dues payment. We have 447 paid up active members at this time. Our current computer program is not really suited for what we need and the board gave the secretary permission to pursue other programs that would be better suited to our needs. Also, members must inform the secretary with all change of address and new email addresses to keep our records current. This should be on our web site and mentioned in each issue of the "Layout". Our secretary was reminded to send a copy of all minutes to the National TCA office and also a listing of all our upcoming meets. The secretary should always request a hard copy (printed) membership directory from the national office. The Secretaries report was accepted as presented.

Mike Powell presented a copy of our current financial report. By being very careful, we have stayed on budget with a small surplus. Our total assets as of 6/30/09 are \$13,249.18. A full report will be printed in the "Layout". A projected budget for the remainder of the year was distributed and discussed along with a suggested budget for the year 2010. The treasurers report was accepted as presented.

The meeting was adjourned at 7:32 P. M.

Mike Powell, treasurer, gave his financial report to the membership. It can be read in the board minutes in the preceding set of board minutes. Report accepted.



Lee, but she is well-known because she was hijacked from the Big Shanty depot northwest of Atlanta in 1862 by a group of Union soldiers known as Andrew's Raiders. Conductor William Fuller pursued Andrew's Raiders until they abandoned the General about 20 miles south of

Your family is invited to attend "Trains at the Holidays" at Central Florida Community College, December 12-30 (except Christmas Eve and Christmas Day). The hours will be 11 a.m. to 5 p.m. The Ocala campus is off SR200 a little more than a mile east of I-75.

Trains of many gauges will be run in the Webber Center Gallery by the Ocala 3-Railers and the Ocala Model Railroads Historical Preservation Society.

My exhibit there will be people movers—trolleys by Lionel and others, plus cable cars.

You can see what the General really looked like from some of the 4-4-0 models of different kinds in my display. You might try to identify how many Generals are among my little models. Some are brass, bronze, cardboard, cast iron, ceramics, coal, glass, leather, plastic, pottery, and wood.

#### **Quiz Corner, by Charles Anyan**

The Quiz Corner quiz for last issue was: How many postwar <u>freight</u> trains can you identify that do <u>NOT</u> have "Lionel" or "Lionel Lines" somewhere on at least one of the cars? The little "Blt by Lionel" on cars is OK.

One of the answers is: Set # 2291W from 1957, a colorful set from a colorful era. It contains the new-for-1957 2379 Rio Grande AB F-3 with the matching 6657 Rio Grande caboose; 3562-75 orange operating barrel car; 3530 generator car; 3444 animated gondola; and the 6464 M&StL boxcar. This is one of the few times that Lionel made a matching caboose for the engine.

While looking through some of my post-war catalogs, I noticed two more sets in the 1954 catalog that qualify. Do you want to look them up yourself, or should I tell you? OK, I'll tell you. They are set # 2217WS "Freight Master" with the 682 Pennsylvania steam turbine with matching caboose, and set # 2219W "The Thunderbird", with the Lackawanna FM trainmaster, and a 6417 Pennsylvania? caboose. There are probably more – I didn't look through all catalogs. Incidentally, all these sets are O gauge: I never found an O-27 set that did not have "Lionel" on it somewhere.

The next quiz departs from toy trains, and moves to the real train world. This should be OK, because if you like trains, it shouldn't matter what gauge they are.

**The question is: Who invented the steam locomotive?** The answer may surprise you. Email me your answer. As usual, the member(s) who supply the correct answer will receive extensive honors in the next Layout.

## Visiting the Birthplace of American Railroading – the B&O Museum in Baltimore, MD By Michael B Powell, Treasurer, TCA Southern Division

For the last 15 years, my trips to the Eastern Division meets at York, PA meant a 5 hour drive South from Rochester NY. The April, 2009 meet was my first since relocating to Florida. To break up the 20 hour drive, I planned a stop at the B&O RR Museum in Baltimore, MD. The museum is on the site of the former B&O Mt. Clare Shops.

I arrived 30 minutes before the museum opened which gave me time to view and photograph the exhibits outside the museum. My wife can attest to the fact that when I visit a Railroad museum I try to photograph every singe piece of RR equipment in their collection. This was quite a challenge at the B&O Museum!

I learned that the Mt Clare area is quite historic. The visitor guide states that Wendell Bollman built the first iron bridges at Mt. Clare; U.S. engineers pioneered engineering techniques here; Alfred Vail received Morse's first telegraphic message at Mt. Clare; and railroad air-conditioning was developed by the B&O and the Carrier Company in a small test shop behind the museum's roundhouse.

The roundhouse is definitely the centerpiece of the museum. Built in 1884, the roundhouse has 22 sides and the roof towers 135 feet above the floor. The Museum's largest steam engine, the C&O 2-6-6-6 Allegheny #1604 at 125 ft 7.9" long could stand on its end and not reach the ceiling of the roundhouse. One advantage of visiting on a Tuesday is with fewer people in the museum that day I got a personal tour of the roundhouse instead of being in a large group of people. Most of you will remember that a half of this roundhouse collapsed on February 16, 2003, damaging many one of a kind railroad exhibits. My tour guide explained the restoration process was done in a manner that looks authentic, but incorporates modern construction techniques that will prevent any future problems. Also, most of the damaged exhibits have been repaired and are back on display. The tour of the Roundhouse traces the development of railroading in America, starting with Peter

Cooper's "Tom Thumb" built in the mid-1830's, and includes the B&O 4-2-0 "Lafayette" which was the first engine to utilize a horizontal boiler, Paris-Lyon-Mediterrannee Railway "40 & 8" Boxcar No. J57121 sent to the US as part of a



"Gratitude Train" in 1948, and B&O 0-8-0 #57 "Memnon" with blind (flangeless) center drivers built in 1848. As luck would have it, my visit occurred just before the "Thomas the Train" weekend, and the staff was busy all day moving equipment in the yard in preparation for the expected crowds. This afforded a unique opportunity to photograph some of the equipment as it was being repositioned. Although I was "trapped" in the paint shop for a few minutes while one move was completed, this just left me plenty of time to photograph the C&O Allegheny, C&O 4-6-4 Hudson #490, and B&O EA #51 along with the other exhibits in the paint shop.

Before leaving I made sure to visit the fine collection of railroad Models including one of my favorite Railroad, the Chicago & Northwestern, the excellent collection of railroad clocks and watches, and the gift shop. All in all it was a most enjoyable day of learning, photographing, and experiencing the history of railroading in America, and I wholeheartedly encourage anyone visiting the Baltimore area to make time to visit the B&O Railroad Museum.
