

Southern Division of TCA Board of Directors Meeting Minutes Friday- Aug. 19, 2011 Boca Raton Marriott

The Meeting was called to Order at 3:24 P. M. by the President. Secretary Dennis called the roll with the following present; Charles Anyan, President; Dienzel Dennis, Secretary; Arnie Travitsky, past president; Steve Harris, past president, and guests Jake Jacob and Linda Harris. Vice President Herron and Treasurer Powell were unable to attend due to prior commitments.

The president reported on tomorrows meet at the Lake Worth Polish Center. Every thing is shaping up to be a great meet with 63 tables assigned. The meet was advertised in 5-6 different papers as well as train forums, T. V., Radio, and magazines. Table holder badges are printed and are ready to be handed out at the door.

Jake Jacob, our web site manager discussed (4) ideas he had concerning making the page more attractive to both members and general viewers. We will publish the TCA version of the standards on our site. The president will send Jake our BOD policies and procedures to be published. Collectibles for sale will only be included as needed. Mr. Jacob will write a survey and send to the president for his approval before including it on our site.

The TCA Convention report is available to THE SD officers who wish to see them. We previewed pictures of the 2012 and 2013 TCA convention cars. We also discussed the "Attendance Award" for the Atlanta Convention and what we can do to promote this within our division.

We went into Executive Session at 4:14 and back out at 4:39. Advertising Strategy for the Maitland meet was discussed. Ideas were presented and will be implemented for this meet.

After discussing Sympathy cards for deceased SD members, it was decided to let the individual board members respond as they wish.

The TCA has given the Southern Division Officers permission to use the TCA logo for Official Documents.

Arnie Travitsky will be the Chairman and head up the new "S. D. Kids Club"

Secretary Dienzel Dennis reported that we have **475** active members in our Division, with 120 inactive and 20 deceased during the last four years. We still have about 75% involvement after the last 5 years. This is a tremendous number for our Club. Our last number assigned is 2606

In the absence of Treasurer Powell, Secretary Dennis presented the financial report. As of June 30, 2011 (Second Quarter) all bills have been paid and we have assets of \$19, 854.48 We also showed a \$336.74 profit from the Jacksonville meet on 05/21/11.

The awards committee reported while we were in executive session. Mike Powell and Charlie Anyan are serving as the Bylaws Committee and are bringing us into compliance with the TCA standard. Arnie Travitsky and Bill Kotek have been appointed to serve with Chairman Steve Harris on the Standards Committee.

Arnie reported on the next meet which will be held at Maitland. Things are coming together including the banquet and open house. The only thing is that Arnie needs some more local help. President Anyan gave some preliminary plans for the Largo meet.

We next discussed the 50th Anniversary car and the dismissal of the submarine car. The 2012 SD train meets have been scheduled as follows: January 29 at Largo, Fl.; March 24 at Stuart, Fl.; May 19 at Jacksonville, FL.; August 18, at Lake Worth, FL.; and November 17 at Maitland.

Suggestions for Honorary membership in the Southern Division was discussed and tabled since the TCA is doing away with theirs. We will have both TCA and SD applications on the meet tables from here on and also plenty of them available at the Front Desk of each meet.



Several switches and buttons mounted on the side of the layout control various operating accessories and lights. We will be adding skirting around the bottom of the layout.
