# VICE PRESIDENT'S CORNER by Jay Zschau

At a time when many organizations are losing members, it is encouraging to see that Southern Division (SD) is increasing its membership. Our current roster reflects 437 paid members. Part of the growth and stability in membership can be attributed to the membership drive we undertook last year when we recruited 63 new members! A side benefit of that effort was the fact that many people who did not immediately sign up did so after they learned of the benefits of becoming a member of the Southern Division. SD members receive: a break on table rentals (\$20 vs \$30); free admission to train shows; receive our second-to-none newsletter, *The Layout*; and admittance to our social events and layout visits, all which play a major role in attracting and retaining members. Perhaps, however, the best benefit is becoming associated with and sharing camaraderie with all of the wonderful Division members at our train meets and social events. The SD has a wealth of interesting and knowledgeable members (and not just about trains, either).

We are considering a similar membership drive early next year. But this membership drive will be different in that all of us will become membership recruiters. So how will we do that? All SD members will receive two application forms: one for membership in the National TCA and one for membership in the Southern Division. These application forms can be duplicated. A benefit to the you the recruiter is that if you sign up enough new members you can win a \$500 gift certificate from National for use at a dealer's where you can purchase \$500 worth of trains or train accessories. #### FORT PIERCE MEET STORY January 25, 2020

The Fenn Center, 2000 Virginia Ave., Fort Pierce, FL 34982 (772-462-1521) again will serve as the host venue for our 2020 train meet.

**Meet Hours:** 8:30A to TCA members and 9:00A-2:00P to the general public

Admission: \$5.00/person with free admission to a child 12 and under when accompanied by an adult

<u>Workshops</u>: Several operating layouts will be on display, but there is room for many more. If anyone wishes to bring a layout or knows someone or a club that might be interested, please contact Meet Host Al Galli.

**Hotel**: There is no designated meet hotel but several, reasonably priced, are located at I-95, Exit 129.

**Food:** Coffee, drinks and snacks will be offered for sale at the Fenn Center.

<u>Table Holders</u>: Early set up currently is scheduled for Friday the 24th from 1:30-3:30P and 7:00-9:00A on the day of the meet. All table holders are asked to contact me the week of January 13th to confirm that these will be the hours for set up. Electrical power is available (no extra charge), but please specify on your registration form. Send your completed Table Registration Form <u>and payment in advance of the meet</u>. This year, there will be no "pay upon arrival."

<u>Tables</u>: 8 feet, \$20 for TCA members and \$30 for TCA non-SD members - remember that all helpers must be a spouse or a current member of the TCA in good standing, unless pre-approved by the meet host or a board member.

**<u>Note</u>**: An SD Board of Directors meeting is scheduled for Friday the 24th beginning at 3:00P at the Fenn Center. Any SD member is invited; but if you wish to attend, contact VP Jay Zschau prior to the meeting.

<u>Directions</u>: From I-95, take Exit 129. Go East on Rt. 70 (Okeechobee Rd.) for 1/2 miles. Turn RIGHT on Virginia Ave. Go 1.6 miles to the building on the left. From the Florida Turnpike, take Exit 152. Go EAST on Rt. 70 for 2.1 miles. Turn RIGHT on Virginia Ave. Go 1.6 miles to the building on the left.

<u>Set Up</u> for table holders will be Friday, 10A-5P and Saturday, <u>8</u>-9A (per contract with the venue). During set up, the building only will be open to table holders and authorized helpers. Remember to list on the Registration Form the full name(s) of any helpers. All helpers must be a family



member or a current member of the TCA in good standing, unless pre-approved by the meet host or a board member. On Friday the 21st, we must vacate the building not later than 5P.

<u>Tables</u>: 8 feet, \$20 for TCA members and \$30 for TCA non-SD members. Due to many, early table presales (table holders from other meets and repeat table holders), remaining tables are limited. Please look over your inventory and see what "extra" cars you can spare for this purpose. The cars should be in clean, in good or better condition, and be complete with all of the wheels and couplers.


One lucky person at each table will be awarded the centerpiece as a "door prize" to take home, so your donated cars will not be returned to you.

# TCA Southern Division Board of Directors Meeting Minutes Morocco Shrine Center, Jacksonville, FL November 22, 2019

President Steve Johnson called the meeting to order at 3:15 p.m.

Secretary Dienzel Dennis called roll with the following in attendance: President Johnson; Secretary Dennis; Treasurer Mike Powell; Communications Officer Bill Trappen; Past President Charlie Anyan; TCA 2020 Convention Treasurer Marianne Napolitano; and *The Layout* Editor Mary Anyan. Jacksonville Meet Host Chuck Bryner and Orlando Meet Host Mike Mills briefly attended.

#### Meet Reports

<u>Jacksonville, 11/23/19</u>: Mr. Bryner reported that over 60 tables are sold for tomorrow's meet, with 12 table holders on a wait list. Four, historical societies will have displays as well as Operation Life Saver. Advertising was extensive. (Contact Bill Trappen for the full list.) The Morocco Shrine Center has a contract to be sold, pending a rezoning issue. A new venue is being researched for 2020.

#### TCA Southern Division, Board of Directors Meeting Minutes, November 22, 2019 (cont'd.)

<u>York, 10/17-19/19</u>: Mr. Johnson reported that the SD had five tables in the Silver Hall, next to Registration (high traffic area), dedicated to promoting the 2020 Convention. Interest was positive, over \$2000 in shirts and caps were sold, and many "giveaway" items were distributed.

Fort Pierce, 1/25/20: (See the Meet Story on p. 4 in this newsletter.) Flyers will be available at tomorrow's show.

<u>Pinellas Park, 2/22/20</u>: Mr. Anyan distributed flyers to the board, and they also will be given to table holders at tomorrow's show. Interest is rapidly growing for the new venue, and only 25 tables remain unsold. (The Meet Story appears on p. 5 in this newsletter.)

<u>Orlando, September 2020</u>: Mr. Mills reported that the date will be September 26. Much discussion ensued regarding changes for events, and they will be outlined in a future newsletter.

<u>Motion</u>: Present awards at a banquet after the November 2020 Jacksonville show as opposed to after the September Orlando 2020 show. A vote was taken, resulting in five (5) yeas and zero (0) nays.

#### Officer's and Committee Reports

Secretary's Report: Mr. Dennis reported that the SD roster currently reflects 437 Active members.

<u>Treasurer's Reports</u>: Mr. Powell provided financial documents to the board and a 2020 budget (included in this issue of the newsletter). Much discussion followed regarding the need to increase SD revenue, and several suggestions were offered, to begin in 2021. The board will further discuss this topic during future meetings and conference calls.

Along the line of increasing revenue, a discussion followed regarding show table holders who sign up for table(s) in advance but do not pay in advance and advise the Meet Host that they will pay at the door. Many times, these table holders fail to show up for the meet and fail to contact the Meet Host. This creates issues in that the Meet Host may have a wait list, and then revenue to the SD is lost. While the board realizes that unforeseen circumstances arise, they have a fiduciary responsibility to the entire SD membership.

<u>Motion</u>: Beginning with the Fort Pierce show January 25, 2020, any table holder who requests table(s) must pay for them in advance of the show. If said table holder fails to notify the host or a board of directors member at least 24 hours prior to the start of the show that they will be unable to attend, they will be invoiced for the amount of table(s) requested. A vote was taken, resulting in four (4) yeas and one (1) nay.

Mr. Powell additionally directed that in the interest of economizing, future issues of *The Layout* are to be kept to a maximum of 16 pages.

<u>Communications Officer's Report</u>: Mr. Trappen reported that: 1) He has been working on advertising for the Jackson-ville show. 2) He submitted ads for the Fort Pierce and Pinellas Park shows to TCA National as well the usual train magazines. 3) He distributed upcoming SD show flyers and table registration forms plus convention information at various Florida meets. 4) He continues to work with Webmaster Bill Porter regarding new website content. and 5) He continues work as Convention Car Chairman.

<u>Webmaster's Report</u>: Mr. Trappen provided the board a copy of Mr. Porter's report which revealed that: 1) Orders for Convention items are steady. 2) Photos, information, etc., are posted on Facebook at least once a week. 3) Members' layout photos and stories are welcomed and encouraged to decorate the website, especially photos of Christmas layouts; and information regarding sending photos to the webmaster is found on the website's <u>home page</u> in a large red box near the bottom of the page.

<u>The Layout Report</u>: Mrs. Anyan reported that articles, etc., for the Winter issue (usually distributed between Christmas and New Year) are due to her not later than December 1.

2020 Convention Planning Update: Mr. Johnson reported that: 1) After tomorrow's meet, he is hosting a Convention-Planning Committee Meeting.
