



The national publications are being distributed on schedule, the convention cars are available for order and, in fact, being delivered on time, the collector insurance is still operational, and many other aspects of the TCA are functioning as usual. On the bright side of train meets and events, several divisions in Pennsylvania recently held an outdoor event near Lancaster; and it was an overwhelming success! Some of the Pennsylvania divisions are planning to replicate that outdoor event in the Spring of 2021 and, if possible, to expand it. The Southern Division also is planning an outdoor parking lot event next March, and the indoor events are still being studied to see how we can continue them while keeping the health and safety of everyone the top priority.

The bottom line is that the TCA is still here, as strong as ever, with plans to bring back the fellowship, train events, and train meets bigger and better than ever. So let's all keep our chin up and enjoy the many things we have planned for the future and a better time. And, above all . . .

TCA Southern Division Board of Directors Teleconference Minutes August 26, 2020

A Board of Directors teleconference call was held August 26, 2020, beginning at 3:30 PM EDT. The meeting was called to order by President Steve Johnson.

Board of Directors Participants: President Steve Johnson; Interim Vice President Al Michelini; Treasurer Mike Powell; Communications Officer Bill Trappen; and Past President Charlie Anyan. A quorum was present.

Guests: Jay Zschau, TCA National Vice President; Bill Porter, SD Webmaster; Marianne Napolitano, SD Convention Treasurer; Dave Zitnik, SD Member; and Mary Anyan, *The Layout* Editor

Jay Zschau reported regarding TCA National: 1) The "WIN BIG" Program initiative is in its second year, and the deadline has been extended to September 30, 2020. Although the website currently lists gift certificates as top prizes, Visa gift cards are now being offered in place of the certificates; Mr. Zschau encouraged all to recruit new members; 2) As the York October 2020 show was cancelled, the regularly scheduled Executive Board Meeting will be held by video or teleconference call not later than December 31, 2020; 3) Many train shows around the country have been cancelled for the remainder of 2020; 4) The 2021 convention plans in Irvine, CA, continue to move forward; 5) The 2025 proposed Jacksonville convention details are still in negotiations between TCA and Hyatt representatives; and 6) Mike Powell asked Mr. Zschau the status of recruitment letters to TCA Florida members not currently SD members. Mr. Zschau replied that the letters are printed and ready for mailing and asked for a volunteer to complete the task.

Steve Johnson provided information regarding the 2020 Convention. The SD has sold a few more convention items since the June 1 teleconference, and an updated order form will be included in the Fall newsletter. Mr. Johnson and Marianne Napolitano provided the most up-to-date convention financial status.

Mike Powell reported that the SD's 2020 2Q Treasurer's Report will be included with the Fall issue of the newsletter.

Bill Trappen reported that: 1) Additional D56 Water Towers have been sold and are still being offered via the SD's website and Facebook page; 2) Dave Zitnik offered to display and sell the water towers in his store, and the board accepted. Details will be finalized in the near future as Steve Johnson will ship a box of four (4) towers to Zitnik Trains; and 3) It was suggested to list the water towers for sale on eBay which Mr. Trappen will do. In addition, two more convention cars were delivered to members since June 1; and there is only one remaining to be produced and delivered.

Bill Trappen reported that: 1) With the cancellation of all central Florida local train shows, he has been unable to distribute flyers and table registration forms for SD; 2) He prepared and submitted a list of SD meets for the September issue of TCA National Headquarters News; 3) For the summer newsletter, he prepared a mailing label file with approximately 200 members who request hard-copy newsletter distribution and emailed the file to the printer; and 4) He e-blasted the newsletter to approximately 200 SD members. Regarding getting the word out about the cancellation of the Orlando-Lake Nona meet: 1) He e-blasted an announcement to 350 SD members as well as to 30 Orlando area train collectors which included some who are not SD members; 2) He posted announcements on the OGR Forum and the TTML; and 3) He made phone calls to several members he personally knows who do not have email or do not regularly check it.

Bill Porter reported: 1) The SD website is running smoothly. Bill Trappen sent convention cars photos which are on the website; however, Mr. Porter again requests that members submit photos of their trains, layouts, etc. to populate the site. 2) The SD Facebook page is working properly. 3) The logistics and financial cost of creating a "Members Only" link to the SD website was discussed, and Mr. Porter and Steve Johnson will continue to research this possibility.

Mary Anyan reported that items for the fall issue of *The Layout* are due to her by September 1.

September 26, 2020, Lake Nona Meet: Bill Trappen advised that he and Mike Mills will begin research on a 2021 meet.

November 21, 2020, Jacksonville Meet: Steve Johnson reported that it officially is cancelled.

January 23, 2021, Fort Pierce Meet: Steve Johnson reported that, at present, the meet is still a "go." As reported in the summer newsletter, the Fenn Center is not executing new contracts but is holding the January 23 date for the SD. Barring cancellation, the Meet Story will appear in the winter issue of *The Layout*. The Board advises members to frequently check the SD website for updates or contact Meet Host Al Galli: 772-219-7653 or algalli@embarqmail.com.

Pinellas Park Meet 2021: The SD was unable to reserve a February or March 2021 Saturday at the Pinellas Park Performing Arts Center as they were already booked. Al Michelini suggested the SD hold an outdoor meet, Dave Zitnik offered his store parking lot, the board discussed logistics, and agreed to Saturday, March 6, 2021, with a rain date of Saturday, March 13. The Meet Story will appear in the winter issue of *The Layout*.

As reported in the June 1, 2020, BOD Teleconference Minutes, Steve Johnson appointed Bill Trappen to serve as chairman of the SD Nominating Committee. The appointment was rescinded during the current teleconference, and Mr. Johnson appointed Charlie Anyan to serve as chairman. As the term for the current Southern Division Board of Directors ends December 31, 2020, a vote must be conducted to elect officers to serve January 1, 2021, through December 31, 2022. The ballot is included in this issue, and instructions are on the ballot. The board encourages the members to vote.

The next SD board meeting is scheduled for September 23, 2020, and the board discussed using Zoom, Microsoft Teams, or Skype as a platform. Steve Johnson volunteered to research.

Meeting adjourned at 5:15 PM EDT.
