Vice President's Viewpoint by Mike Mills


Regarding the Recruiting Campaign for the TCA and the SD, let's take a look at the timeline:

1) Mid-April 2024 in York — Setzer, Powell, Zitnik and Quinn met. 2) Early- and mid-May 2024 — two Zoom meetings with SD BOD members and Dave and Gale Zitnik were held to brainstorm and finalize dates, times, etc. for the September 5th gathering. 3) Mike Powell and the Zitniks created two documents: a Zitnik Trains internal e-blast and a Flyer; 4) Mary Anyan created a two-sided informational document (taken from the TCA and SD websites) which will be handed out Sep. 5th. 5) Marketing: the TCA will send an e-blast to all TCA members living in Florida; Gale Zitnik will e-blast to her list of over 2000 customers; SD members will see the invitation in this newsletter as well as on the SD website and SD Facebook page; copies of the Flyer and its attachment will be taken to Florida train shows. (If anyone wants copies for a train show, let me know and I'll see that you get them if I'm not already going to that show.)


The timeline is to give you *some* idea of how many hours your SD Board of Directors, in addition to the always supportive Zitniks, already have invested in this. More importantly, it should tell you how much we believe in the sustainability of the TCA and the Southern Division. On September 5, Setzer, Dennis, Trappen and I plan to travel across the state to Pinellas Park to show support to attendees. We'll have to overnight, spend our time and money for gas and lodging, and we receive only a <u>small</u> stipend from the division. If this is successful, we'll consider other Florida venues.

To reiterate what Mike Setzer said, "ask yourself what <u>you personally</u> can do to increase membership in TCA national and your division."

TCA Southern Division Special Meetings via Zoom May 7 and May 23, 2024

Minutes

Two special meetings were held for the purpose of discussing recruiting efforts for the TCA and the SD. Both meetings were called to order at 6:00 PM EDT. Attendees for both meetings included: SD President Mike Setzer; Vice President Mike Mills; Secretary Dienzel Dennis; Treasurer Mike Powell; Communications Officer Bill Trappen; Past President Charlie Anyan; Dave and Gale Zitnik, owners of Zitnik Trains in Pinellas Park, FL; and *The Layout* Editor Mary Anyan.

After much brainstorming and discussion, it was decided that the SD and the Zitniks will host a "**TCA Night at Zitnik Trains**." The event will be held Thursday, September 5th, 2024, at Zitnik Trains from 6:00-8:00 PM. The SD will provide a light dinner, beverages, door prizes, etc. As an added bonus, the Zitniks will offer a 10% discount on new, in-stock purchases from their shop that evening. A valid TCA card must be presented at the register.

Various forms of advertising will include: 1) an e-blast by TCA to all TCA members living in Florida; 2) an e-blast by Zitnik Trains to their current e-mail list of customers; 3) Flyers at Florida train shows; and 4) the SD's website and Facebook page.

The board agreed that anyone who joins the <u>SD</u> on September 5th will be charged the annual \$10 fee, and their membership will be considered active until December 31, 20<u>25</u>.

Mr. Mills suggested selling SD t-shirts at the September 5th event. The color scheme on the new shirts will be reversed from the original tees (green lettering on a bright yellow shirt) to yellow lettering on a dark green shirt.

If the September 5th event is successful, the board will consider hosting similar events at venues around the state.

Mr. Setzer advised that Mr. Quinn is very interested in the SD's September 5th recruiting efforts; and, if successful, he would like other divisions to follow suit.

Both meetings were adjourned at 7:10 PM EDT.


